Mr. Vázquez changed the order of the agenda to begin with the 2023 Financial Audit. Due to timing, the audit was not presented to the Audit Committee as it is due into SUNY on November 1, 2023.

# FINANCIAL AUDIT

Two representatives from Bonadio & Co., LLP – Ms. Karen Lynch and Ms. Emily Monnat presented the 2023 Financial Audit. The audit findings indicated that there were significant improvements in the preparedness for the audit, no material weaknesses were identified and that the school's financial statement is strong.

The Audit Committee will comprise of Mr. Vázquez, Dr. Vázquez, and Dr. DeJesús-Rueff. Mr. Caster can't be part of the Audit Committee as it is a conflict of interest due to EMHCS doing business with the accounting firm he works for – FreedMaxick.

The 2023 Financial Audit was presented for approval. Ms. Pérez-Delgado moved the motion, and Dr. DeJesús-Rueff seconded. The motion was approved unanimously.

Mr. Vázquez and the board chairs will conduct a new board member orientation with both new parent representatives after their acceptance from SUNY. Ms. Serrano will schedule a meeting for next month.

The two parent representatives, Ms. Rosemary Johnson and Ms. Glorida Soldevila, were presented for approval. Ms. Torres moved the motion, and Mr. Meléndez seconded the motion. The motion was approved unanimously.
